Tour Policies

1. The two front seats directly behind the driver are reserved for the tour escort and the group leader.
2. Punctuality is required to ensure itinerary scheduling. Please arrive ½ hour prior to departure.
3. Each traveler is required to sign and mail a customer-disclaimer form to *the Tulsa Historical Society*, registering for the trip. (Your check for the full amount of the trip is your reservation.)
4. Package price includes transportation, accommodations, tickets for special events, meals, taxes and gratuities, unless otherwise specified. Driver's gratuity is always included in the package price.

The tour participant agrees that *Karen's Tours, Inc. (KTI)* or the *Tulsa Historical Society (THS)* shall not be liable for any damage, loss (including personal injury, death and property loss) or expense occasioned by any act or any omission of any supplier providing tour services. *KTI* and the *THS* reserve the right to alter or curtail the itinerary and substitute transportation, accommodations and/or entertainment providers as it deems necessary, and to provide comparable alternates. *KTI* and the *THS* bears no responsibility for loss of any personal belongings or damage to the tour participant's vehicle. Trip insurance for the traveler or personal goods is the responsibility of the traveler. Handicapped persons who need assistance should be accompanied by a qualified assistant. *KTI* and the *THS* reserve the right to terminate the tour of any persons who are objectionable to other passengers or who disrupt the operation of the tour.
